



# COVID-19 Impact and Recovery Report: Travel-Related Measures

Updated: April 7, 2022

This document provides an evergreen assessment of the situation in Canada. It has the following sections:

## 1. TRAVEL-RELATED MEASURES

Please consult the Government of Canada website for the latest federal travel requirements: <a href="https://travel.gc.ca/travel-covid">https://travel.gc.ca/travel-covid</a>. Below is a summary of recent updates to federal travel requirements and advice:

#### As of April 1:

- Pre-entry tests are no longer required for fully vaccinated travellers entering Canada; fully vaccinated travellers may still be selected for random tests on arrival but are not required to quarantine while awaiting their results.
- Unvaccinated or partially vaccinated travellers still require pre-entry tests, an on-arrival test and a day 8 test, and must quarantine for 14 days.
- All travellers continue to be required to submit their mandatory information in ArriveCAN (mobile app or website) before their arrival in Canada.
- For 14 days following entry into Canada, all travellers must wear a mask in both indoor and outdoor public spaces, maintain a list of all close contacts and locations visited, and keep copies of proof of vaccination.
- Cruise ships: Passengers must take a molecular test within 72 hours before boarding a cruise ship or an
  antigen test within 24 hours of the scheduled departure. They no longer need to be tested leaving the
  cruise ship.
- Travellers aged 12 years and older, with very limited exceptions, are required to show their <u>Canadian COVID-19</u> proof of vaccination to depart from Canadian airports, on VIA Rail and Rocky Mountaineer trains, and on non-essential passenger vessels (e.g. cruise ships) on voyages of 24 hours or more departing from ports in Canada. To qualify as fully vaccinated, travellers must have received the full series of an accepted COVID-19 vaccine (or a full series of a combination of accepted vaccines), with the last dose at least 14 full days prior to the date of travel.

In addition to federal government travel requirements, individual provinces and territories have implemented measures on travel between provinces and territories. The table below outlines self-isolation requirements for domestic and foreign travellers entering into each province or territory, as well as restrictions on travel across provincial and territorial borders. Tracking these measures is challenging given the fluid nature of COVID-19. This information, collected by provincial and territorial tourism marketing authorities and relevant tourism departments, is current as of April 7, 2022.

Most provinces and territories have implemented a framework to guide reopening strategies catered to their individual circumstances. Since each province and territory is starting from a different baseline to implement the reopening of their local economy, the phases and stages are not congruent across jurisdictions. The table below outlines the current status of restrictions on tourism-related sectors as of April 7, 2022. Unless noted, persons must gather and business must operate with sufficient social distancing measures in place. Many destinations require non-medical masks to be worn and all visitors should plan on having masks ready if needed.
